	Cover letter completely filled on https://applyvisa.um.dk/ , printed and signed by the applicant.
	Visa Fee payment receipt printed from https://applyvisa.um.dk/
	The Original passport should be valid for at least 3 months (any other type of travel document should be valid for at least 6 months), beyond the intended duration of stay in the Schengen territory and with at least two blank page to affix the visa. The passport must have been issued within the last 10 years.
	Copy of previous visas and stamps of the applicant's old passport(s) if any.
	Copy of name or surname change certificate, if applicable.
	Proof of integration : into the country of residence: Household registration record.
	Proof of occupation. - If the applicant is employed: 1) the last three payslips, 2) labour contract or original documents confirming employment at recent date. - If the applicant is a company owner or self-employed: certificate of registrations of the company* and statement of taxes payment are required. - If the applicant is retired: Pension statement is required
	Documents from sponsor/host in Denmark: □ Certificate of enrolment at an education establishment for the purpose of attending vocational or theoretical courses within the framework of basic or further training □ Student cards or certificates of the courses to be attended □ If the applicant is sponsored and/or hosted in a private accommodation: - Invitation/guarantee letter - A copy of passport or national identification card of the sponsor/host in Denmark - If the sponsor/host is a foreigner, a copy of permanent residence permit is also required. - Bank account statements on the turnover during the last three months of the sponsor/host when its/his/her financial means are not proven otherwise.
	Documentation of funds to cover the trip. According to the Danish Immigration Service you must have the necessary means to pay for your stay and return trip. As a general rule, you must have at your disposal approx. DKK 350 per day if you are staying in a private home and your host will cover all costs. If you are staying at a hotel, the amount must be greater, approx. DKK 500 per day. You can find further information https://www.nyidanmark.dk/ - Other means (if any): Remittances, credit cards, regular incomes generated by property can also be submitted
	Proof of lodging: Hotel reservation, rental of holiday home, campus residence reservation – if not hosted in a private accommodation.
	Round trip ticket. Flight/train/ferry reservation with fixed travel dates of maximum 90 days to Denmark and other Schengen countries. (Do not buy the ticket until a visa has been granted).
	Original compulsory travel medical insurance, covering the entire of intended stay, valid for all Schenger countries covering any medical expenses of at least 30,000 Euro as well as urgent medical attention, emergency hospital treatment or death during your stay, repatriation to Vietnam/resident country

Note: Official documents marked with * must be verified by the competent local authority. Verification must be maximum 3 months old. A certified translation in English must be attached to any documents in Vietnamese.
